We also celebrated the success of our inaugural Junior Firefighter Academy, a four-day immersive experience for youth aged 12 to 15, designed to spark interest in fire and EMS careers. Planning is underway for the 2025 academy, and we are excited to continue inspiring the next generation of public safety professionals.





























### **NIST Drone Certification**

Lake Travis Fire Rescue hosted a regional NIST train-the-trainer course, enhancing drone proficiency in partnership with regional fire agencies. This first-of-its-kind course in Texas certified pilots and proctors to a nationally recognized standard, ensuring measurable and repeatable UAS proficiency. By achieving this certification, LTFR is strengthening emergency response capabilities and setting a new benchmark for public safety drone operations.







# **NIST-Approved Training Course**

Lake Travis Fire Rescue developed a NIST-approved UAS training course, making LTFR the first in the region to implement this updated standard. With its completion, all NIST Levels (1-5) are now available at the Training Center for pilot proficiency and real-world drone operations.

### **K9 Ember Joins LTFR**

In 2024, K9 Ember joined Lake Travis Fire Rescue, becoming a vital part of our fire investigation team. As an ignitable liquid detection K9, K9 Ember works alongside her handler, Assistant Fire Marshal Ryan Smith, to support fire investigations by detecting trace amounts of accelerants. Originally awarded to Travis County Emergency Services District No. 12 (ESD12) in 2022 through a generous grant from

K9s4COPs—funded by Ms. Jean Goodwin of Texas— K9 Ember transitioned to Lake Travis Fire Rescue when her handler, Ryan Smith, joined Lake Travis Fire



Rescue. K9 Ember's extraordinary sense of smell allows her to pinpoint areas where potential evidence can be collected and sent for laboratory analysis, significantly improving the accuracy and efficiency of fire investigations. Her nose is so sensitive she can detect ignitable liquids at concentrations as low as one part per trillion, making her an invaluable tool in identifying the presence of accelerants.

### **K9 Casualty Care Class**

Lake Travis Fire Rescue hosted a K9 Casualty Care Course taught by the experts from Memorial Hermann Life Flight and the Houston Police Department. This specialized training brought together 22 K9 handlers and those working with police K9s to learn lifesaving skills for responding to working dog injuries.

# Wildfire Mitigation

The Wildfire Mitigation Division at Lake Travis Fire Rescue takes proactive measures to reduce the risk and impact of wildfires in the region. Through strategic vegetation management, community outreach, and comprehensive planning, they work to create defensible spaces, raise awareness about wildfire risks, and enhance overall preparedness.



### **Steiner Ranch Fuels Mitigation Projects**

Lake Travis Fire Rescue successfully completed two community fuel mitigation projects in Steiner Ranch, in partnership with volunteers from the Steiner Ranch Firewise group and LTFR's Fuels Mitigation crew. These efforts focused on reducing wildfire risk by removing ladder fuels, dead vegetation, and smaller trees—critical steps in creating defensible space. Additional projects are planned to continue strengthening wildfire resilience in the community.











### **Blue Bluff Project**





In Spring 2024, the Blue Bluff Fuel Mitigation Project reduced wildfire risk by treating hazardous fuels and strengthening firelines to support future prescribed burns. Managed by the Travis County Fire Marshal's Office and completed by the LTFR Fuels Crew with funding from ESD4, the project was a collaborative effort with Travis County Parks and partner agencies, enhancing long-term wildfire resilience.







# **EMS Education**

The EMS Education Coordinator at Lake Travis Fire Rescue is committed to advancing the knowledge and skills of emergency medical services personnel. They design and deliver comprehensive training programs, ensuring that EMS professionals receive up-to-date education on the latest medical techniques and protocols.

In 2024, Lake Travis Fire Rescue (LTFR) launched the NFPA "Steps to Safety" program to address the increasing fall risks identified within our district. This home safety initiative is designed to help older adults reduce their risk of falls and fires, two of the leading causes of injury in this age group. The program provides simple, actionable steps to enhance home safety, such as removing tripping hazards, installing smoke alarms, and planning emergency exits. By focusing on education and practical strategies, Steps to Safety empowers older adults to live safely and independently in their homes.














# Fleet & Logistics




1 Truck Refurbished

# **Presentations & Partnerships**



Every year, Lake Travis Fire Rescue provides lunch to the dispatchers and communications team who provide dispatch services for LTFR.






