## **Notice of Public Hearing** on Tax Increase

A tax rate of \$0.090399 per \$100 valuation has been proposed by the governing body of Travis County Emergency Services District No. 6.

PROPOSED TAX RATE \$0.090399 per \$100

NO-NEW-REVENUE TAX RATE \$0.087231 per \$100

VOTER-APPROVAL TAX RATE \$0.090399 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Travis County Emergency Services District No. 6 from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that Travis County Emergency Services District No. 6 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Travis County Emergency Services District No. 6 is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 24, 2025 at 3:30 p.m. at Lake Travis Fire Rescue Headquarters, 15304 Pheasant Lane, Austin, TX 78734.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Travis County Emergency Services District No. 6 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Administrative Division of Travis County Emergency Services District No. 6 at their offices or by attending the public hearing mentioned above.
